TO THE ORDINARY GENERAL ASSEMBLY

Dear Shareholders,

We are hereby submitting for approval the Financial Statements of the Company for the financial year ended on 31/12/2023. The financial statements were prepared according to the International Financial Reporting Standards.

1. GENERAL

MERMEREN KOMBINAT AD-Prilep (the "**Company**") operates according to the Law on trade companies (Gazette of RM no. 28/96) of the Republic of North Macedonia and its prime activities are exploitation, processing and trade of marble and decorative stones. The quarry, the factory and the administration headquarters of the Company are located in Prilep.

2. IMPORTANT EVENTS OF THE YEAR 2023

On 13 January 2023, the Company was informed that the shareholders of Pavlidis S.A Marble-Granite ("Pavlidis") had signed a definitive agreement with funds managed by ECM Partners to sell 100% of Pavlidis shares, which owns 100% of the equity of Stone Works Holding Cooperatief UA, the holder of 89,25% of the Company's issued share capital. The transaction was completed on 10 March 2023, Dolit Investments SA ("Dolit") acquired Pavlidis and the ultimate parent of The Company became ECM Partners Inc Ljubljana Slovenia as indirect 100% owner of Dolit. On 13 March 2023, the President of the Board of directors Mr. Christoforos Pavlidis resigned.

On 10 April 2023 Mr. Nikolaos Dimarelis was elected as President of the Board of Directors with decision number 02-1547/2.

On March 30, 2023, the Company received notification that Dolit Investments SA ("Dolit") intended to launch a takeover bid for the ordinary shares with voting rights issued by Mermeren. The bid was concluded successfully on May 23 and subsequently confirmed by the Security Commission on June 21, 2023.

On 30 May 2023 Mr. Lazaros Pantelidis was elected as a non-executive member of the of Board of Directors under decision number 02-2325/9. Subsequently, on May 31, 2023, he was appointed as President of the Board of Directors under decision number 02-2353/3.

On 23 August 2023 the Company was informed that Mr. Christoforos Pavlidis had acquired 100% of the equity interests of Dolit Investments, which owns Pavlidis Monoprosopi A.E Marmara-Granites (formerly known as Pavlidis S.A Marble–Granite).

On 10 October 2023 Pavlidis Monoprosopi A.E Marmara-Granites proceeded to a takeover bid for the ordinary shares with voting rights issued by Mermeren. The bid was concluded successfully on November 07 and subsequently confirmed by the Security Commission on November 11, 2023.

3. 2023 OPERATING PERFORMANCE

- Turnover for the period was lower by 3.7% compared to 2022.
- Gross profit was at 65.0% of the turnover compared to the gross margin 65.9% in 2022. Coupled
 with the lower sales, in absolute figures the gross profit decreased to €19.0 million, from €20.0
 million in 2022.
- Total administrative and sales expenses decreased by 12.9% compared to 2022, mainly due to lower product transport cost.
- The company registered operating profit before interest and taxes ("EBIT") of €14.9 million versus
 €15.4 million in 2022.
- The earnings before interest, tax, depreciation and amortization ("EBITDA") for 2023 decreased to €17.2 million vs €17.6 million in 2022.
- Earnings after tax ("EAT") were €13.7 million and the corresponding figure of 2022 €14.0 million.
- No bank loans existed as on 31 December 2023, same as on 31 December 2022. Only €56 k linked to financial leasing appear as borrowings.
- Equity was at €35.7 million on 31 December 2023, compared τo €41.0 million on 31 December 2022.

4. ALTERNATIVE PERFORMANCE MEASUREMENT INDICATORS (APM)

The Company uses Alternative Performance Measurement Indicators ("APM") in the context of decision-making regarding its financial, operational and strategic planning as well as for the evaluation and its performance. They serve to better understand the financial and operational results of the Company, its financial position as well as the cash flow statement. The alternative indicators should always be taken into account in conjunction with the financial results prepared in accordance with IFRS and in no case replace them.

Definitions and Agreement of Alternative Performance Measures ("APM") a) Profitability indicators

The Company, in order to more fully analyze its operating results, uses the following profitability indicators:

Gross profit

Gross profit results directly from the statement of comprehensive income.

EBIT (Earnings before taxes and interest)

The EBIT is equal to the operating profit resulting from the statement of comprehensive income.

EBITDA (Earnings before taxes, financing and investing activities, depreciation and amortization)

The EBITDA ratio is calculated from the statement of comprehensive income as "Gross operating profit" plus "Other operating income" less "Administrative operating expenses" and "Disposal operating expenses" before depreciation.

EBT (Profit before tax)

EBT is the profit before the deduction of taxes and it results from the statement of comprehensive income.

Net profit

Net profit is the EBT after deduction of taxes and results from the statement of comprehensive income.

Margins

For all the above profitability indicators, the corresponding margin is calculated by dividing the corresponding indicator by the total sales.

5. MAIN RISKS AND UNCERTAINTIES

5.1 SUPPLIERS - INVENTORY

The company has no significant dependence on specific suppliers since it exploits marble reserves on the basis of a long-term concession agreement. Consumables and spare parts are purchased from a diversified basis of domestic and international reliable sources.

5.2 CLIENTS

The major volume of trading in 2023 was directed to South–East Asia. The Company's management believes that the Company is well positioned to face any difficult economic circumstances, on the back of the following factors:

- The Company has a diversified group of old and new customer relationships, most of them on a long-term basis.
- According to the Company's policy, all major customers' exposures are secured with different types
 of collaterals such as bank guarantees and cash deposits. Credit quality of trade receivables as at 31
 December 2023 is considered to be very good.
- The Company's major customers have not experienced financial difficulties, while they operate on a global market.

Overall, the Company is in a strong position and has sufficient capital and liquidity to serve its operating activities and debt. The Company's objectives and policies for managing capital, credit risk and liquidity risk are described in its recent annual financial statements.

5.3 BORROWINGS

The company cooperates for its financing with Komercijalna Banka A.D., a local bank. No loans stood as of 31 December 2023.

5.4 FOREIGN EXCHANGE & INTEREST RISK

Foreign Exchange Risk. The Company operates internationally and is exposed to foreign exchange risk arising from various payables and receivables primarily with respect to the Euro. The Company does not use any instrument to hedge the foreign exchange risk. The sensitivity analysis includes only monetary items denominated in foreign currencies at year end, and a correction of their value is made for a 1% change in the exchange rate of Euro and for 5% change in the other foreign currency rates. The positive or negative amount indicates increase/decrease in profit or other equity, which occurs when the Denar weakens/strengthens its value against the Euro by +/- 1% and against other foreign currencies by +/- 5%.

Interest Rate Risk. Interest rate risk is the risk that the fair value of future cash flows of a financial instrument will fluctuate because of changes in market interest rates. The Company's exposure to the risk of changes in market interest rates relates primarily to the Company's long-term debt obligation with a floating interest rate. The Company's management is primarily responsible for daily monitoring of the net interest rate risk position and it sets limits to reduce the potential of interest rate mismatch.

The Company is certified with ISO 14001:2015 Environmental management systems and ISO 45001:2018 Occupational health and safety.

6. RESEARCH & DEVELOPMENT

The company conducts drilling research inside its quarry concession. The entire amount spent for drilling research is fully immobilized. In 2023 the amount spent in drilling research was €9k (2022: €146k)

7. DIVIDEND POLICY

At 11 December 2023 and according to the Shareholders' Assembly decision no. 02-5470/2, part of the retained earnings realized till 31 December 2022 in the amount of 19,028,643 Euros were allocated for dividends distribution.

During the period ended 31 December 2023 the Company paid dividends to its shareholders in net amount of 18,820,554 Euros and in addition 204,050 Euros relating to taxes on dividend paid.

13. CORPORATE GOVERNANCE

Corporate Governance principles that the Company follows

In the reporting year, the Company has performed its activities with two bodies: Shareholders Assembly and Board of Directors.

The Shareholder Assembly of the Company held its regular meeting on May 30, 2023 on which the shareholders voted for and approved: (1) The annual accounts for the period 1stJanuary to 31st December 2022; (2) the Financial Statements and independent auditor's report for 2022; (3) The report of the Board of Directors on the operations of the Company for the year 2022; (4) The allocation of the profit of 2022; (5) The approval of the work of the members of the Board of Directors during the year 2022; (6) The Annual Report of the Internal Audit for 2022; (7) The appointment of auditors for the audit of the financial statements and annual accounts of the Company for the year 2023; (8) The election of Mr. Lazaros Pantelidis as member of the Board of Directors; (9) The re-election of Mr. Vasileios Anagnostou as member of the Board of Directors.

One extraordinary meeting was also held, on December 11, 2023 which decided distribution of dividend, as described in paragraph 7.

During 2023 the Company did not conclude any major transaction such as selling property over 20% of the NBV of the total assets or major transactions with interested parties from which a conflict of interest might arise.

The Board of Directors has performed its duties according to the Law on trade companies and the Statute of the Company, held a total of 14 sessions and undertook all necessary activities to provide for the proper operation of the Company.

Description of the internal control and internal management systems

Internal Control: The BOD is responsible for reviewing the effectiveness of the Company's system of internal control. The internal auditor submitted the appropriate reports timely.

Code of Business Conduct: The Company maintains a Code of Business Conduct and Ethics, including anti-Bribery Policies, which applies to all employees and is signed by all employees.

Organizational Structure: A clear organization structure exists, detailing lines of authority and control responsibilities. The competence of staff is maintained both through rigorous recruitment policies and a performance appraisal system.

Roles and Responsibilities: There are documented approval limits by the Board of Directors for all forms of payments, receipts, bank transfers, and also other responsibilities. Furthermore, there are job descriptions for all positions.

Information Systems: Information systems are developed to support the Company's decision – making processes.

Planning & Monitoring: There is a detailed annual and monthly budget, which was subjected to adequate scrutiny and approved by the Board of Directors. Comparisons are made between actual, historical and budgeted revenues, costs and K.P.I.s with adequately detailed explanations obtained for all significant variances.

Management Accounting System: A detailed management accounting system is in place providing management with financial and operational performance measurement indicators. Detailed management accounts are prepared monthly to cover each major area of the business. Variances from plan and previous forecasts are analyzed, explained and acted on. As well as regular Board discussions, weekly meetings are held by the Senior Management team to discuss performances.

All mentioned above about the financial condition of the Company can be found in the Financial Statements of 31 December 2023.
